Symptom(s): Diagnosis: **Case 11:** Barney Hauser was from a very strict, devoutly religious family and had been brought up with a strong sense of the horrible price a person paid for sin, whether actually committed or committed through fantasy. During his senior year in high school, his parents decided to obtain a divorce. Shortly after they separated. Barney had a dream which recurred frequently in later weeks. In the dream, Barney was told that he was a recreation of Jesus Christ, and the "Son of God would be thrown out of the house of God." As the dream repeated again and again, he came to believe it was true, and he thought of a way to test the dream's truth. In the poorest section of his city was an old church called the "House of God". Since this was the phrase that turned up in his dreams, Barney visited the minister of his church to ask his advice. The minister quickly realized how disturbed Barney was and asked him to leave, but Barney refused and began to pound on the desk in his excitement. The noise brought some men from the store next door, and they held Barney while the minister called the police. Barney was taken from the church to the nearest Psychiatric hospital. He seldom talked with the other workmen and preferred to eat his lunch alone. When he was twenty-five years of age, he became even more withdrawn and began to behave strangely. At times he would refuse to eat, especially some articles of food, for fear of being poisoned. He quit his job and stayed at home, often not leaving the house for several days at a time. At times he even locked himself in his room. He was taken to a mental hospital, where he remained withdrawn. At times his facial expression became rather unchanging. Sometimes he would not answer questions directed to him. He would sit alone for considerable periods of time without making any noticeable movements. In expressing his thoughts he jumps from one topic to another without following any particular course. If, while he is talking about his family, the psychologist suddenly interjects a comment about the weather, John immediately switches his conversation to the weather or any other topic the psychologist introduces. Furthermore, he is hyperactive. He is either drumming with his fingers, playing with a pencil, or engaging others with his rapid talk.
