The Superintendent recommends approval of the following personnel items for the 2024-2025 school year as presented by the Director of Human Resources.

1.) Darcy Klimkowski - Will resign her position as Fifth Grade Teacher at Center Elementary, effective July 31, 2024.

It is recommended that Darcy Klimkowski be approved as Assistant Elementary Principal at Center Elementary effective August 1, 2024, for the 2024/2025 school year and be given a three-year (205 day per year) administrative contract with an annual salary of \$102,868 (step 4) and with all the emoluments and entitlements contained in the administrative compensation schedule.

2.) Shawn Cramer - Will resign his position as Fifth Grade Teacher at Lander Elementary, effective July 31, 2024.

It is recommended that Shawn Cramer be approved as Assistant Elementary Principal at Lander Elementary effective August 1, 2024, for the 2024/2025 school year and be given a three-year

(205 day per year) administrative contract with annual salary of \$93,577 (Step 0) and with all the emoluments and entitlements contained in the administrative compensation schedule.


