0155 - COMMITTEES

The Board may authorize the establishment of committees from among its membership as it finds such action necessary to study operations in specific areas and to make recommendations for Board action.

The following guidelines may govern the appointment and function of Board committees.

A. The committee is established through action of the Board.

B. The chairperson and members are named by the Board President.

C. A committee chairperson shall call meetings of the committee, keep informed on

developments in activities under the committee's jurisdiction, and report to the Board for the committee.

D. The committee may make recommendations for Board action but may not act for the Board unless specifically authorized.

E. The Board President and Superintendent are ex officio members of all committees.

F. No committee appointments extend beyond the ensuing annual organizational meeting, at which time the newly elected President has the privilege of making new appointments or reappointments. A committee may be dissolved at any time by a majority vote.

G. The Sunshine Law and its exceptions apply to Board meetings and Board-appointed committee and subcommittee meetings.
