Dear Mayfield Teachers, Students, Staff and Families,

I am thrilled to be able to welcome back our students. It has been more than 170 days since students, teachers and staff have been together in our schools since the pandemic began last spring. This is a much anticipated reunion.

3-WEEK PHASE-IN TO IN-PERSON LEARNING

As you know, Monday, September 21st begins the first of a three-week phase-in to in-person learning for students and families who have chosen the in-person learning option.

The remote-online option remains in place for those students and families who choose to continue to learn remotely. Whether in person or remote, we remain Mayfield Together. Let's continue to do the great work we began in August.

We are offering the three-week, phase-in to in-person learning before our proposed 9-week period because of the ongoing decline in state, county and local COVID-19 trend data. If, however, local and county trend data were to significantly rise, we will revert back to a full remote model of learning. As I communicated in my last email, there is no hard and fast metric for a decision to return to full remote leaning. Our decision will be based on several data points and recommendations from the Board of Health.

For those students and families who have chosen the in-person learning option, the three-week, phase-in schedule will be:

September 21

- All students in grades PK, Kindergarten, 1, 2, 6 and 9
- Cosmetology students
- CEVEC

September 29

• All students in Grades 3, 4, 5 and 7

October 5

- All students in Grades 8, 10, 11 and 12
- Excel TECC programs housed at Mayfield

Building principals have also communicated specific details for schools and grades related to the in-person and/or remote-only learning options. Please refer to those communications or contact your students' school building with specific questions.
